2. the signature below confirms acceptance of the terms of this agreement and that if this document is completed on behalf of a company or partnership then my signature is confirmation that I will ensure that other parties involved with me in this process will be bound by the same terms;
3. the signing and returning of this document is not an entitlement to receive the confidential information, which may be withheld at the discretion of Charterfields Limited or Company;
4. the information provided is offered in good faith and that neither Charterfields Limited nor Company offer any warranty in respect of the completeness or accuracy of such information and it is confirmed that all information provided will be checked by me or my appointed advisors before it is acted upon.

Nothing in this agreement will restrict the undersigned in respect of the lawful use of information which, before entering into this agreement, was in the possession of the undersigned or was in the public domain.
